There will be no ingress or egress over the following described Controlled Access Line located in the South Half of the Northeast Quarter of Section 14, Township 14 North, Range 11 East of the 6th P.M., Sarpy County, Nebraska, described as follows:

Referring to the East Quarter Corner of said Section 14; thence northerly on the East Line of the South Half of the Northeast Quarter of said Section 14 a distance of 1322.3 feet to the Northwest Corner of said South Half of the Northeast Quarter; thence westerly on the North Line of said South Half of the Northwest Quarter a distance of 80.8 feet to the point of beginning; thence southerly a distance of 204.1 feet to a point 77.5 feet westerly from said East Line of said Northeast Quarter; thence continuing southerly a distance of 102.0 feet to a point 55.9 feet westerly from said East Line; thence continuing southerly a distance of 74.5 feet to a point 54.7 feet westerly from said East Line; thence continuing southerly a distance of 150.0 feet to a point 52.3 feet westerly from said East Line; thence continuing southerly on a 11,369.16 foot radius curve to the right a distance of 251.2 feet to a point of tangency, said point being 51.4 feet westerly from said East Line; thence continuing southerly, tangent, a distance of 471.2 feet to a point 55.0 feet westerly from said East Line; thence southwestwardly a distance of 222.0 feet to a point 39.0 feet northerly from the South Line of said South Half of the Northeast Quarter to a point of termination of said Controlled Access Line.

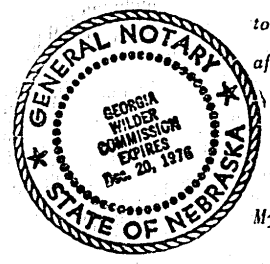
