LANDSCAPE SETBACK RESTRICTIVE COVENANT FOR COLBY WOODS WEST PLAT NO. 7

WHEREAS, the undersigned are the record titleholders of all of the real estate included within the plat known as Colby Woods West Plat No. 7 in the City of Urbandale, Polk County, Iowa; and

WHEREAS, the undersigned owners deem it desirable for the efficient preservation of the value of their property within the plat and in the surrounding areas, and in order to comply with the requirements of the City of Urbandale, Iowa, to adopt the following covenant for the mutual benefit and protection of themselves and all others who may purchase, acquire or have any interest in such property or any portion thereof.

NOW, THEREFORE, in consideration of the premises, the undersigned by their execution and recording of this Restrictive Covenant declare the following covenant to be binding upon the land described herein and upon its owners and their heirs, successors and assign, as follows:

- 1. All existing trees and shrubs and other plant material currently located within the 30-foot wide landscape setback running across Lots 1 through 7 of Colby Woods West Plat No. 7 shall be maintained in a healthy, neat, clean and weed free condition. Dead plant material shall be replaced with plant material of substantially equal size and maturity, and any tree replacements shall be made with equivalent caliper inches of new trees.
- 2. Each owner of a lot within Colby Woods West Plat No. 7 shall be responsible for the performance of this covenant with regard to the portion of the landscape setback area located on their lot.
- 3. The covenant herein shall be deemed appurtenant to and shall run with the land, and the owner of any lot to which this covenant applies, or the City of Urbandale, may bring an action in any court of competent jurisdiction to enforce this covenant and enjoin its violation, or for damages for the breach thereof, or for any other remedy or combination of remedies recognized at law or in equity.
- 4. This covenant may be amended from time to time by an affirmative vote of all of the then owners of lots within Colby Woods West Plat No. 7 and the approval of the City of Urbandale.
