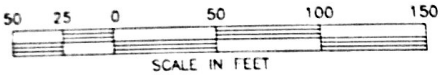


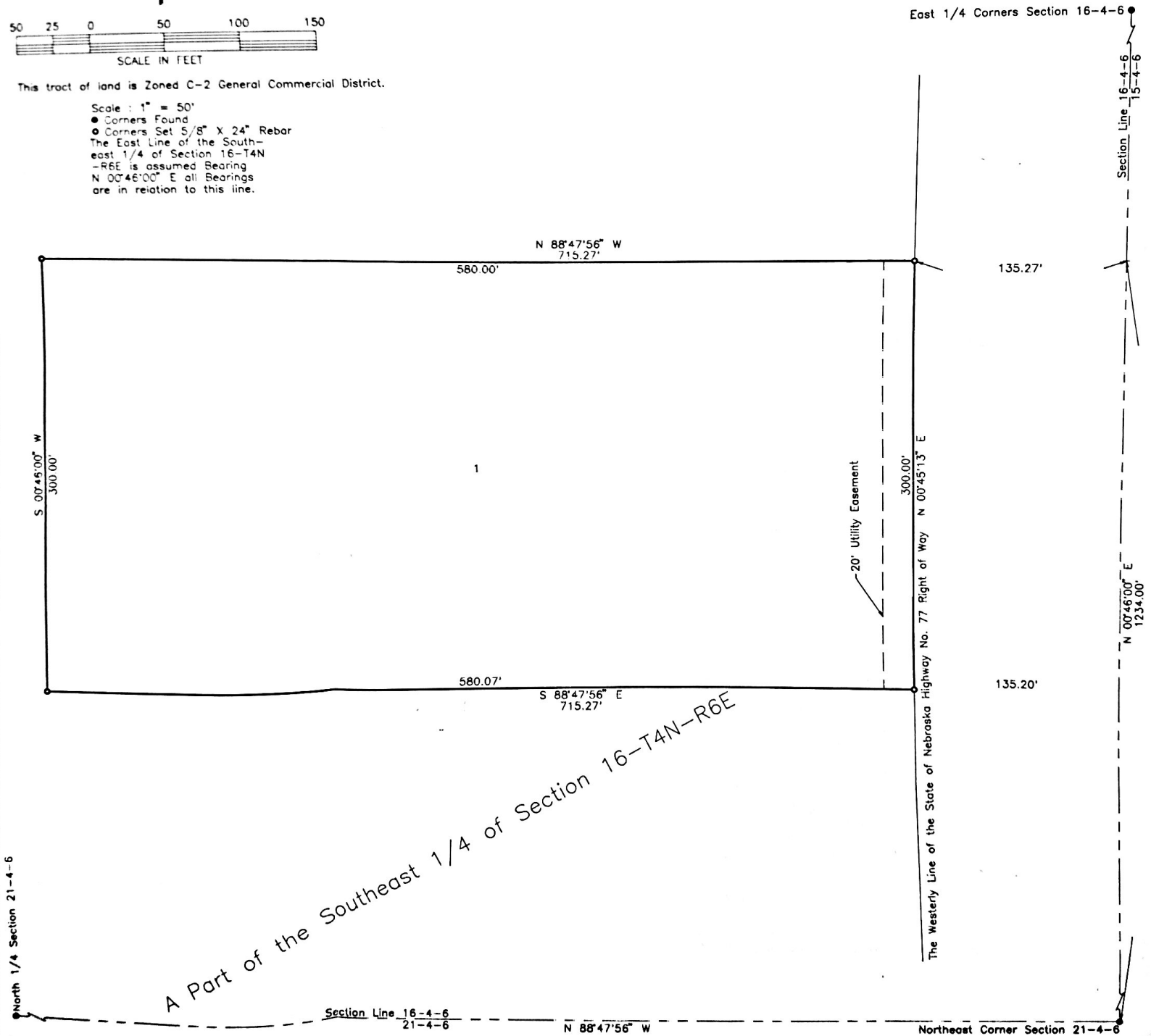
# BURNHAM ADDITION TO THE CITY OF BEATRICE, NEBRASKA

"BURNHAM ADDITION" on Addition as platted on a part of the Southeast Quarter (1/4) of Section Sixteen (16), Township Four (4) North, Range Six (6) East of the Sixth Principal Meridian, Gage County, Nebraska.

**DEDICATION**

**DESCRIPTION:**

The foregoing subdivision of a part of the Southeast Quarter (1/4) of Section Sixteen (16), Township Four (4) North, Range Six (6) East of the Sixth Principal Meridian, Gage County, Nebraska, more particularly described as follows:

Commencing at the Southeast Corner of the Southeast Quarter (1/4) of Said Section Sixteen (16), thence Northerly along the Easterly Line of the Southeast Quarter (1/4) of Said Section Sixteen (16) a distance of One Thousand Two Hundred Thirty-four (1234) feet to a point; thence Westerly along a line One Thousand Two Hundred Thirty-four (1234) feet Northerly from and parallel with the Southerly Line of the Southeast Quarter (1/4) of Said Section Sixteen (16) a distance of One Hundred Thirty-five and Twenty-seven Hundredths (135.27) feet to the point of beginning, Said point being on the Westerly Line of the State of Nebraska Highway Seventy-seven (77) Right of Way; thence continuing Westerly along the last described course a distance of Five Hundred Eighty (580) feet to a point; thence Southerly along a line Seven Hundred Fifteen and Twenty-seven Hundredths (715.27) feet Westerly from and parallel with the Easterly Line of the Southeast Quarter (1/4) of Said Section Sixteen (16) a distance of Three Hundred (300) feet to a point; thence Easterly along a line Nine Hundred Thirty-four (934) feet Northerly from and parallel with the Southerly line of the Southeast Quarter (1/4) of Said Section Sixteen (16) a distance of Five Hundred Eighty and Seven Hundredths (580.07) feet more or less to a point on the Westerly Line of the State of Nebraska Highway Seventy-seven (77) Right of Way; thence Northerly along the Westerly Line of the State of Nebraska Highway Seventy-seven (77) Right of Way a distance of Three Hundred (300) feet more or less to the point of beginning. Containing and area of 4 acres more or less.

**EASEMENTS:**

The Easements shown on this plat are hereby dedicated for public use, as well as Easements of record.

**STREETS:**

Streets shown on this plat and not heretofore dedicated to public use are hereby so dedicated.

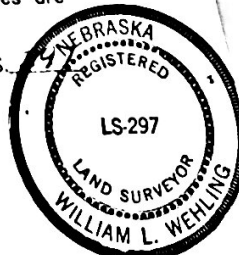
