

QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS. That BURLINGTON NORTHERN INC., a corporation organized under the laws of the State of Delaware, successor in interest to Chicago, Burlington & Quincy Railroad Company, Grantor, in consideration of Six Hundred and no/100 Dollars (\$600.00), to it duly paid, the receipt whereof is hereby acknowledged, has granted, conveyed, remised, released and quitclaimed, and by these presents does grant, convey, remise, release, and forever quitclaim unto the COUNTY OF DODGE, NEBRASKA, a body politic of the State of Nebraska, Grantee, all its right, title, interest, estate, claim and demand, both at law and in equity of, in and to the following described real estate, to-wit:

TRACT ONE

A tract of land located in the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section 11, Township 17 North, Range 8 East of the Sixth Principal Meridian, containing 0.91 acre, more or less, of which 0.12 acre, more or less, is new right of way acquired, Dodge County, Nebraska, and being more particularly described as follows:

Commencing at the Northeast corner of said Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$), said corner being the point of beginning; thence South along the East margin of said Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) for a distance of 37 feet; thence West, parallel to and 57 feet South of the North margin of said Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) to a point 50 feet Easterly at right angles from the center line of Burlington Northern Inc.'s main line railroad track; thence Northeasterly, parallel with and 50 feet from said center line of Burlington Northern Inc.'s main line railroad track to a point on the North margin of said Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$); thence East along the North margin of said Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) to the point of beginning.
