

RESOLUTION

Supervisor Hintz made the following Resolution and moved its adoption, seconded by Supervisor Racek:

WHEREAS The Chicago, Burlington and Quincy Railroad Company has filed an application requesting the designation of certain areas as an Industrial Zone as is provided in Chapter 19, Article 25 of 1943 Revised Statutes as amended, and

WHEREAS notice of the filing of said application and hearing thereon has been given as is provided for by law, and

WHEREAS this Board upon consideration of the facts finds:

1. The hereinafter described tract is suitable for use as an industrial area;
2. It will be generally beneficial to the community to have the same so designated and used.
3. The owners of the land have consented to have the same designated as an industrial area as is provided for by law.

NOW THEREFORE, it is resolved that the following described real estate be designated as an industrial area as is provided for in Chapter 19, Article 25 of 1943 Revised Statutes of Nebraska as amended.

THOSE PARTS OF SECTION ELEVEN, TOWNSHIP SEVENTEEN NORTH, RANGE EIGHT, EAST OF THE SIXTH P. M. DODGE COUNTY, NEBRASKA, DESCRIBED VIZ:

THAT PART OF THE EAST HALF OF THE NORTHWEST QUARTER LYING SOUTH OF THE CHICAGO, BURLINGTON & QUINCY RAILROAD COMPANY RIGHT OF WAY AND NORTH OF THE CHICAGO & NORTHWESTERN RAILWAY COMPANY RIGHT OF WAY; ALSO, THAT PART OF TAX LOT 12 IN THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER LYING NORTH OF THE CHICAGO AND NORTHWESTERN RAILWAY COMPANY RIGHT OF WAY; ALSO, THAT PART OF THE WEST HALF OF THE NORTHEAST QUARTER LYING NORTH OF THE CHICAGO & NORTHWESTERN RAILWAY COMPANY RIGHT OF WAY; COMPRISING IN ALL 116.2 ACRES, MORE OR LESS, SUBJECT TO DRAINAGE DITCHES AND HIGHWAYS; ALSO, THAT PART OF SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 2, TOWNSHIP 17, RANGE 8, LYING SOUTH AND EAST OF CHICAGO, BURLINGTON & QUINCY RAILROAD RIGHT OF WAY THRU SAID 40 acre Tract.
