ORDINANCE NO. 212

AN ORDINANCE, vacating the way used as an alley running east and west between Lot 6, in Block 15, in Wilber's First Addition and the north end of Lots 26, 27 and 28 in the Original Town, all in Wilber, Saline County, Nebraska; to repeal all ordinances or parts thereof in conflict herewith and providing for the time when this ordinance shall be in full force and effect.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF WILBER, SALINE COUNTY, NEBRASKA:

Section 1. That in pursuance to petition duly presented by all the owners of real estate abutting thereon, the way which has been used as an alley running east and west in Lot 6, Block 15, in Wilber's First Addition and the north end of Lots 26, 27 and 28 in the Original Town, all in Wilber, Saline County, Nebraska be, and the same hereby is, vacated as an alley.

Section 2. All prior ordinances or parts thereof in conflict herewith are hereby repealed.

Section 3. This ordinance shall take effect and be in full force from and after its passage, approval, adoption and publication, as provided by law.
