CRETE SALINE CO NEBRASKA.

Crete is situated in the South East quarter and the S. E. of N. 34 and the E. of the S. 27 and the S. E. of the N. 27 and N. 34 and the N. E. of the S. 27 and the N. W. of the N. 27 and the S. E. of the N. 27 and the North part of the N. E. of the S. 27 of Section N. 27 and N. 34 is 6. of the 6. S. D. containing altogether 7200 acres in Saline County, State of Nebraska. The streets Avenue and Alley run at right angles N and S and E and W parallel and at right angles to the quarter Section line running N and S through Section 27 and 34. Davine Avenue is 80 feet wide, Third Street East of Davine Avenue is 60 feet wide, Third Street West of Davine Avenue is 40 feet wide, Mill Street is 40 feet wide, Western Avenue is 40 feet wide North and South, Railway Streets are each 30 feet wide, the Alley bounding the belt vary in width and are marked on the map. All other streets and Avenues are each 60 feet wide. The Alley immediately North and South of Antiquity Streets are each 16 feet wide all other Alleys are each 20 feet wide. The full blocks fronting on quarter Section line are 258 feet from E to W and 260 ft from N to S. All other full blocks are 260 square. Ordinary sized lots are 66 ft by 122 ft, Square lots are 22 ft by 122 ft the size of all lots streets avenues and Alley are designated in feet on the map. There are stakes driven at the front corners of each lot and stones are planted at the several places marked on the map. I hereby certify the above notes and map are correct.

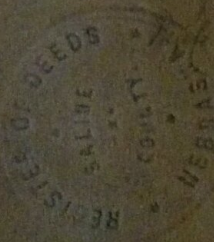

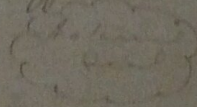
