RESOLUTION NO. A- _____

01 WHEREAS, the City of Lincoln, Nebraska, is authorized under Neb. Rev.
 02 Stat. § 18-2001, et seq., to pave a portion of a street otherwise paved so
 03 as to make one continuous paved street and to do so without petition or
 04 creating a street improvement district; and

05 WHEREAS, a portion of 58th Street between Cleveland Avenue and Madison
 06 Avenue is unpaved and should be paved to make one such continuous paved street.

07 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lincoln
 08 Nebraska:

09 That 58th Street from the south curb line of Cleveland Avenue to the north
 10 curb line of Madison Avenue is hereby designated as Paving Unit No. 60 and
 11 is hereby ordered paved.

12 The roadway to be paved shall be 26 feet in width; grading to be from
 13 lot line to lot line, and the cost of grading, curbing, guttering, and paving
 14 the same; including the cost of grading, curbing, guttering, and paving the
 15 intersections and returns, and the cost of grading the sidewalk space and
 16 relaying the sidewalks, and all expenses incidental to all of said improvements
 17 shall be assessed against the real estate benefited, to-wit: Lots 1, 2, 3, 10,
 18 11 and 12, Block 57; and Lots 4 through 9, Block 58, University Place in the
 19 City of Lincoln, Lancaster County Nebraska, the assessments against said
 20 property benefited to be in proportion to the benefits, not exceeding the cost
 21 thereof. In the event that easements or additional right-of-way must be
 22 acquired for the completion of this project, such property rights may be
 23 acquired by negotiation and purchase or by condemnation, if necessary, as
 24 provided by law.

01 BE IT FURTHER RESOLVED that, in the event that the actual bid price exceeds
02 25 percent over the preliminary cost estimate for the improvements, then such
03 bid shall not be awarded until the Council has approved such bid by resolution.
