An ordinance to extend the boundaries and include within the corporate limits of, and to annex to, the City of Beatrice, Nebraska, part of the Northwest Quarter (NW4) of Section 22, Township 4 North, Range 6 East of the 6th P.M., Gage County, Nebraska; to provide service benefits thereto; to provide for severability; to repeal conflicting ordinances; and to provide for an effective date of this ordinance.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BEATRICE, NEBRASKA:

SECTION 1. It is hereby found and determined by the Mayor and City Council of the City of Beatrice, Nebraska, that:

- (a) The tract of land and streets and highways consisting of part of the Northwest Quarter (NW½) of Section 22, Township 4 North, Range 6 East of the 6th P.M., Gage County, Nebraska, hereinafter more particularly described, are urban and suburban in character and contiguous and adjacent to the corporate limits of said city;
- (b) Police, fire, and snow removal benefits will be immediately available thereto, and city water services will be available as provided by law;
- (c) There is a unity of interest in the use of such tracts of land and streets and highways with the use of lots, lands, streets, and highways in the city, and the community convenience and welfare and interest of said city will be enhanced through incorporating such tracts of land and streets and highways within the corporate limits of said city.

SECTION 2. That the boundaries of the City of Beatrice, Nebraska, be, and hereby are, extended to include within the corporate limits of said city the contiguous and adjacent tracts of lands and streets and highways in part of the Northwest Quarter ( $NW_4$ ) of Section 22, Township 4 North, Range 6 East of the 6th P.M., Gage County, Nebraska, described as follows:

Commencing at a point 48 feet East and 1644.24 feet South of Northwest corner of said Section 22, which said point is in the East line of existing highway right-of-way and being the point of beginning; thence running North along said highway a distance of 300 feet to a point; thence running East a distance of 700 feet to a point; thence running South a distance of 300 feet to a point; thence running west a distance of 700 feet to point of beginning.

SECTION 3. That a certified copy of this ordinance together with a plat of such tracts of land and streets and highways, be filed on record in the offices of the Register of Deeds and County Assessor of Gage County, Nebraska.

SECTION 4. That said tract of land and streets and highways are

hereby annexed to the City of Beatrice, Gage County, Nebraska.

SECTION 5. That upon the taking effect of this ordinance, the police, fire and snow removal services of said city shall be furnished to the tracts of land and streets and highways herein annexed, and water service will be available as provided by law.

SECTION 6. If any section, subsection, sentence, clause or phrase of this ordinance or the annexation of any tracts of land, streets, or highways by this ordinance, is for any reason, held to be unconstitutional or invalid, such decision shall not affect the validity of the annexation of other tracts of land, streets or highways by this ordinance, since it is the express intent of the Mayor and City Council to enact each section, subsection, clause or phrase separately and to annex ecah tract of land separately.

SECTION 7. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 8. That this ordinance shall be in full force and effect from and after its passage, approval and publication according to law.




