## EASEMENT

## WITNESSETH:

THAT, said Parties of the First Part in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, to them in hand paid by said Party of the Second Part, the receipt whereof is hereby acknowledged, doth hereby grant, sell, convey and confirm unto the said Party of the Second Part, and its successors and assigns forever, the right to use, construct, build, lay and maintain a 60" (inch) Sanitary or Storm Sewer pipe for the passage of sewer water and soil in, through and under the parcel of land described as follows, to-wit:

A permanent easement 20 feet in width, being 10 feet each side of the following described line through the Northwest quarter of the Northwest quarter of Section 24, Township 15 North, Range 12 East of the Sixth Principal Meridian, in Douglas County, Nebraska.

Beginning at a point 385 feet North and 40 feet East of the Southwest corner of the Northwest Quarter of the Northwest Quarter of said Section 24; thence East along a line 385 feet North of and parallel to the South line of the Northwest Quarter of the Northwest Quarter of said Section 24, for a distance of 613 feet; thence Northeasterly along a curve to the left whose deflection angle is 90009, Tangent equals 50 feet, Radius equals 50.1 feet, for a distance of 78.67 feet; thence North along the Tangent produced a distance of 240.8 feet, thence Northeasterly along a curve to the right whose deflection angle is 57°42', Tangent equals 50 feet, Radius equals 87.13 feet for a distance of 90.96 feet; thence Northeasterly along the Tangent produced for a distance of 124.5 feet; thence Easterly along a curve to the right whose deflection angle is 33000', Tangent equals 30 feet, Radius equals 101.28 feet for a distance of 58.33 feet; thence Easterly along the Tangent produced for a distance of 407.4 feet more or less to the West property line of 69th Street.

Said easement is granted upon the express condition that if any changes, repairs or alterations are necessary to be made at any time or if any portion of said sewer needs to be reconstructed after the lots are filled or improved, the City shall make good to the owner or owners of such lot or lots, as hereinbefore set forth, any and all damage that may be done by said changes, alterations, repairs or reconstruction, in the way of damage to trees, gounds, buildings or other improvements thereon including crops, vines, gardens and lawns, during construction and thereafter.

Said Party of the Second Part agrees to pay all costs of construction of said sanitary or storm sewer, and fill in the trench with mechanically compacted material and sow grass seed over said trench and generally leave the premises in a neat and orderly condition.

Said Parties of the First Part, for themselves or their successors and assigns, do confirm with the said Party of the Second Part, and its successors and assigns, that they, the Parties of the First Part, are well seized in fee of the lot and premises

aforesaid, and that they have the right to grant and convey this easement in the manner and form aforesaid, and that they will, and their successors and assigns, shall warrant and defend this easement to said Party of the Second Part, and its successors and assigns, against the lawful claims and demands of all persons.
