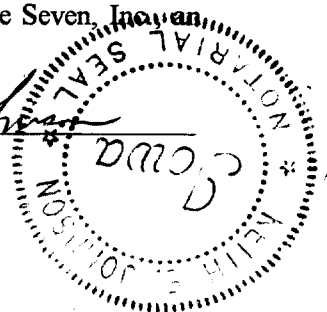

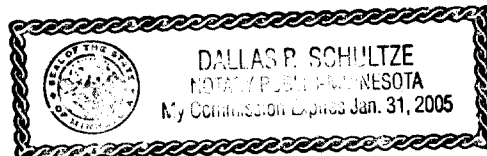


EXHIBIT A
FACILITY SITE DESCRIPTION

That part of the NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 35, T99N, R24W, Winnebago County, Iowa described as follows: Commencing at the NW corner of said Section 35; thence on an assumed bearing of North 90 degrees 00 minutes East, along the North line of said section, a distance of 1439.07 feet to an iron monument, said iron monument being the point of beginning of the tract to be described; thence South 0 degrees 26 minutes 55 seconds East, a distance of 825.00 feet to an iron monument; thence North 90 degrees 00 minutes East, a distance of 750.00 feet to an iron monument; thence North 0 degrees 26 minutes 55 seconds West, a distance of 825.00 feet to an iron monument located on the North line of said section; thence South 90 degrees 00 minutes West, along said North line, a distance of 750.00 feet to the point of beginning.
