MODIFICATION OF DEED OF TRUST



THIS MODIFICATION OF DEED OF TRUST dated May 18, 2015, is made and executed between JOMD, LLC, A NEBRASKA LIMITED LIABILITY COMPANY, whose address is 13467 State St, Omaha, NE 68142 ("Trustor") and GREAT WESTERN BANK, whose address is Great Western Bank - Fremont, 1552 E 23rd Ave N, Fremont, NE 68025 ("Lender").

DEED OF TRUST. Lender and Trustor have entered into a Deed of Trust dated December 9, 2013 (the "Deed of Trust") which has been recorded in Dougas County, State of Nebraska, as follows:

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property located in Dougas County, State of Nebraska:

Lot 2, Cimarron Grove, a Subdivision in Douglas County, Nebraska.

The Real Property or its address is commonly known as 13467 State Street, Omaha, NE 68142.

MODIFICATION. Lender and Trustor hereby modify the Deed of Trust as follows:

INCREASE THE MAXIMUM LIEN AMOUNT TO \$3,509,706.00. THE DEED OF TRUST REFERENCED HEREIN SHALL SECURE THAT PROMISSORY NOTE DATED JUNE 24, 2014 IN THE PRINCIPAL AMOUNT OF \$3,343,265.68 (HEREIN "NOTE") FROM TRUSTOR TO LENDER, TOGETHER WITH ALL RENEWALS OF, EXTENSIONS OF, MODIFICATIONS OF, REFINANCINGS OF, CONSOLIDATIONS OF, AND SUBSTITUTIONS FOR THE NOTE

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
