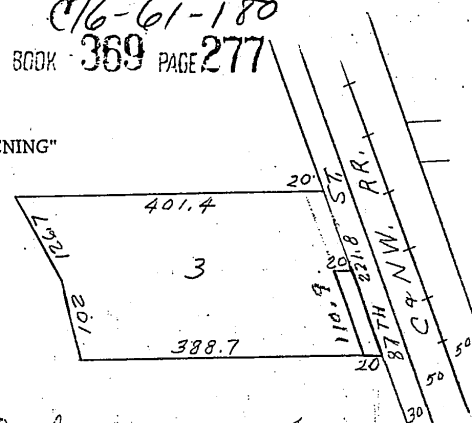


"PLAT & DEDICATION FOR STREET WIDENING"
