Property Described:


The final plat of Woodland Plaza as shown and described on the legal description of said final plat attached hereto and made a part hereof as Exhibit "A."

ANNEXATION OF WOODLAND PLAZA ADDITION



WHEREAS, it is in the best interest of the City of Hickman and its inhabitants that the property described above be annexed into and become a part of the City of Hickman, Nebraska; and



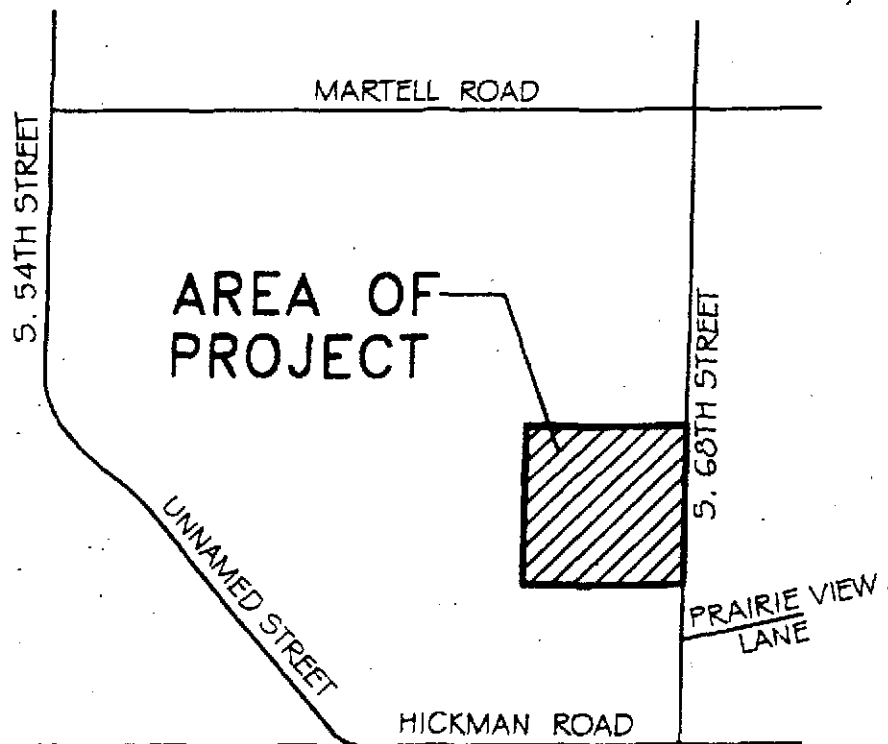

**LEGAL DESCRIPTION**

A survey of the Northeast Quarter of the Southeast Quarter of Section 28 Township 8 North Range 7 East of the Sixth Principal Meridian, Lancaster County, Nebraska. More particularly described by metes and bounds as follows.

Commencing at the East  $\frac{1}{4}$  Corner of Section 28 Township 8 North Range 7 East of the Sixth Principal Meridian, and the POINT OF BEGINNING; Thence South  $00^{\circ}18'25''$  East, (an assumed bearing) on the East line of the Southeast Quarter, a distance of 1318.24 feet to the East  $\frac{1}{16}$  Corner of the Southeast Quarter; Thence South  $89^{\circ}25'01''$  West, on the South line of the Northeast Quarter of the Southeast Quarter of Section 28, a distance of 1320.22 feet to the Center  $\frac{1}{16}$  corner of the Southeast Quarter; Thence North  $00^{\circ}15'07''$  West, on the West line of the Northeast Quarter of the Southeast Quarter of Section 28 a distance of 1317.25 feet to the North  $\frac{1}{16}$  Corner of the Southeast Quarter; Thence North  $89^{\circ}22'26''$  East, on the North line of the Northeast Quarter, a distance of 1328.97 feet to the POINT OF BEGINNING, and containing a calculated area of 1,752,034.58 Square feet or 40.221 acres more or less.

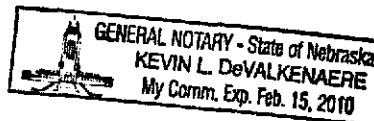
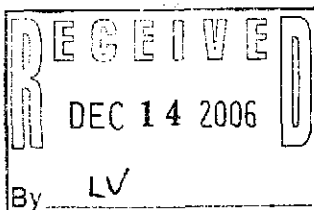
