PERMANENT EASEMENT

A tract of land lying in School Lot, in the South of of the Northeast of Section 10, Township 15 North, Range 12 East of the 6th P.M., Douglas County, Nebraska, more particularly described as follows: Beginning at a point 1,068.52 feet East of and 33.0 feet North of the center Section 10-15-12 on the North R.O.W. line of Maple Street; thence N 80°15'56" E for a distance of 132.07 feet; thence N 66°20'25" E for a distance of 43.90 feet; thence Southeasterly a distance of 34.73 feet; thence West a distance of 179.71 feet to the point of beginning. All bearings given are based on Corps of Engineers Data.

The rights and privileges herein granted shall be subject to the following terms and conditions:

- 1. There is reserved to the Grantor, its heirs and assigns, the right and privilege to use the above described land in any manner and for any purpose not inconsistent with the full use and enjoyment by the County of Douglas, its successors and assigns, of the rights and privileges herein granted.
