AMENDED AND RESTATED DECLARATION OF STORM WATER DRAINAGE EASEMENT

This Amended and Restated Declaration of Storm Water Drainage Easement ("Declaration") hereby amends and restates Instrument Number 2010-07362 filed on March 26, 2010 at the Office of the Register of Deeds, Sarpy County, Nebraska.

SCHEWE FARMS, INC., a Nebraska corporation (the "Grantor"), being the owner of the real estate located in Sarpy County, Nebraska, and legally described on Exhibit "A" attached hereto and incorporated herein by this reference (the "Real Estate"), for and in consideration of the sum of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration, receipt of which is hereby acknowledged, does hereby grant and convey a permanent nonexclusive storm water drainage easement as more particularly described on Exhibit "A" attached hereto (the "Easement Area").

The sole purpose of this Easement is to provide that any storm water will not be allowed to discharge toward Highway 370 or to the 126th Street public right-of-way immediately adjacent to Highway 370, and further, all storm water runoff will be required to be retained within the Easement Area or discharged to the north pursuant to applicable City of Papillion requirements.

Buildings, parking areas, green areas and landscaping may be permitted in the Easement Area so long as any storm water is not discharged toward Highway 370 or the 126th Street public right-of-way immediately adjacent to Highway 370 from the Easement Area. After having received prior written consent from the Nebraska Department of Roads, Grantor and Grantor's successors and assigns may terminate this Declaration when the easement area has been graded and an underground storm sewer system is constructed, both of which do not allow any storm water from Grantor's land to discharge toward Highway 370 or to the 126th Street public right-of-way.


