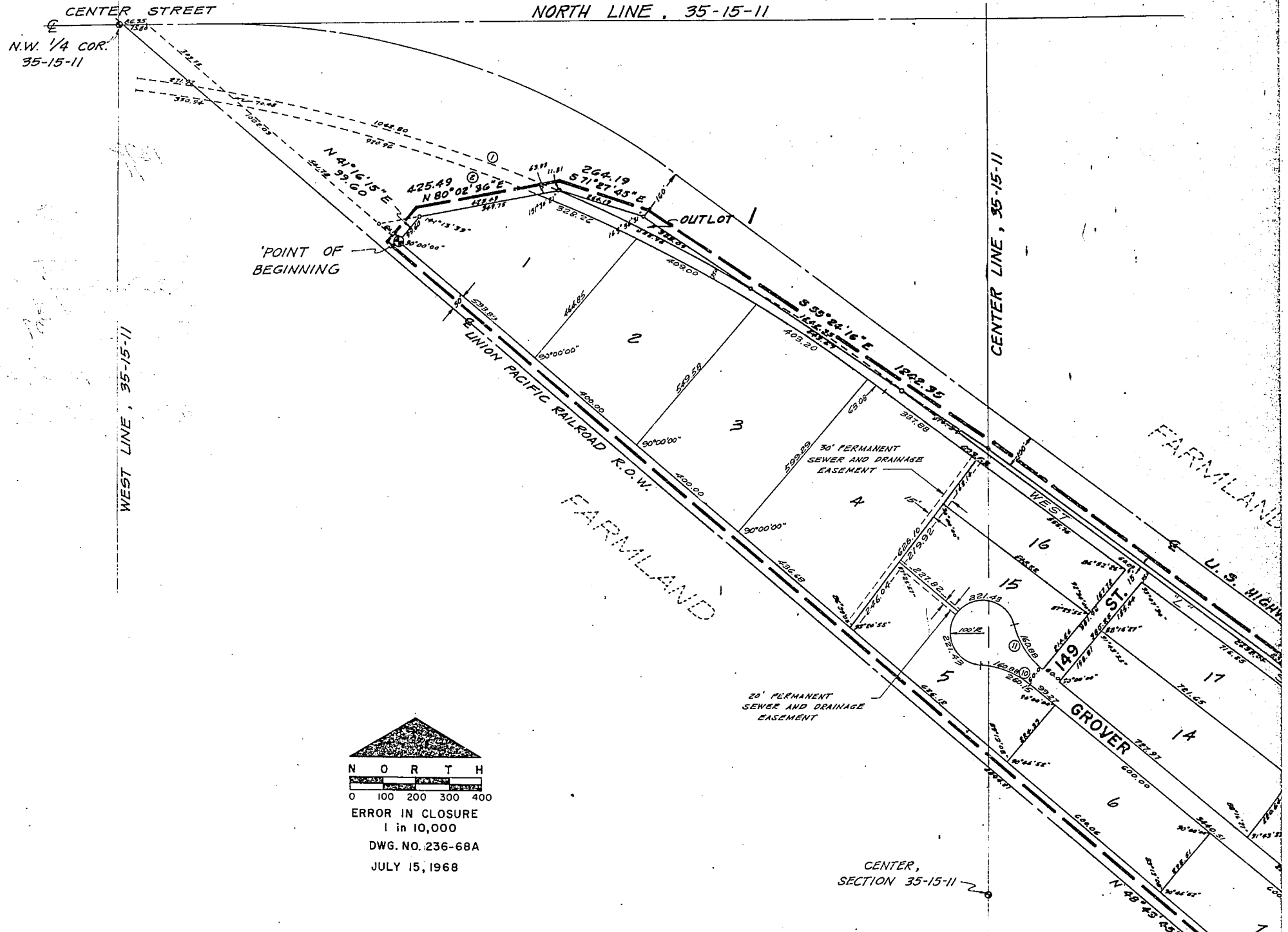


CORNHUSKER INDUSTRIAL PARK III
