Beginning at the SE comer of Tax Lot 3A in said NW 1/4; thence S 00° 19'31"W (assumed bearing) 385.25 feet on the southerly extension of the easterly line of said Tax Lot 3A and on the easterly line of 72nd Street; thence S09°23'I 1"E 283.86 feet on the easterly line of 72nd Street; thence S 00°19'32"W 1090.00 feet on the easterly line of 72nd Street; thence N89°40'29"W 28.00 feet; thence N 00°19'31"E 931.12 feet on a line 28.00 feet westerly of and parallel with the easterly line of 72nd Street; thence northwesterly on a 2075.00 foot radius curve to the left, chord bearing N 05°43'55"W, chord distance 437.92 feet, an arc distance of 438.73 feet; thence N11°47'21"W 379.54 feet to the westerly extension of the southerly line of said Tax Lot 3A; thence N 81°01'10"E 107.39 feet on the southerly line of said Tax Lot 3A and its westerly extension to the point of beginning (containing 1.47 acres more or less). more or less;
