AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS,

This Amendment to the Declaration of Covenants, Conditions, Restrictions, and Easements of West Cornhusker Plaza South and West Cornhusker Plaza made on the date herein after set forth by the undersigned, hereinafter referred to as "Declarants" is made to amend the Declaration of Covenants, Conditions, Restrictions, and Easements of West Cornhusker Plaza South and West Cornhusker Plaza made on October 10, 2008 and recorded as Instrument No. 2008-28323, Register of Deeds, Sarpy County, Nebraska.

RECITALS

WHEREAS, the above stated covenants covered Lot 1 through Lot 9 inclusive and Outlot A, West Cornhusker Plaza South, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska and Lot 1 through Lot 7 and Outlot A, West Cornhusker Plaza, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska; and

WHEREAS, the above stated covenants in Article IV, Section 4.1 provides that the number of Net Acres in a Lot (and the number of memberships attributable to each Lot) are set forth on Exhibit "C".

WHEREAS, Exhibit "C" was omitted from the original Covenants filed with the Register of Deeds; and

WHEREAS, the Declarants as of the date hereof are the owners of seventy-five percent (75%) or more of the lots covered by said covenants.

WHEREAS, the Declarants now desire to amend the above stated covenants to include the attached Exhibit "C".

NOW THEREFORE, the Declarants hereby amend the Declaration of Covenants, Conditions, Restrictions, and Easements of West Cornhusker Plaza South and West Cornhusker Plaza to include the attached Exhibit "C".




