

ORDINANCE NO. 148

AN ORDINANCE TO VACATE CERTAIN STREETS IN THE CITY OF NORTH BEND, DODGE COUNTY, NEBRASKA; TO PROVIDE TO WHOM SAID VACATED PROPERTY SHALL REVERT; TO REPEAL ALL ORDINANCES IN CONFLICT THEREWITH; AND TO PRESCRIBE THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF NORTH BEND, NEBRASKA:

Section 1. That it is for the best interests of the City of North Bend, Nebraska, and to the citizens thereof, that the streets, hereinafter described, be vacated.

Section 2. That that portion of 14th Street lying between Block Five (5) and Block Six (6), Stevenson and Eckhart's Addition to the City of North Bend, in Dodge County, Nebraska, is, and the same is hereby vacated. That the fee title in and to such vacated street shall revert to the adjacent property owner, or owners.

Section 3. That that portion of 11th Street lying between Block Sixteen (16), Stevenson and Eckhart's Addition, and Block Nine (9), Original Town, all in North Bend, Dodge County, Nebraska, be, and the same is hereby vacated. That the fee title in and to such vacated street shall revert to the adjacent property owner, or owners.

Section 4. That a strip of land 14 1/2 feet in width, designated on the recorded plat as Pine Street, lying immediately west of the west edge of Stevenson and Eckhart's Addition, North Bend, Dodge County, Nebraska, be, and the same hereby is vacated. That the fee title in and to such vacated street shall revert to the property owner owning said property immediately east of said vacated street.

Section 5. That all ordinances and parts of ordinances passed and approved prior to the passage and approval of this ordinance and in conflict therewith be, and the same hereby are repealed.

Section 6. That this ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
