DISCLAIMER AND RELEASE

KNOW ALL MEN BY THESE PRESENTS, that **OMAHA PUBLIC POWER DISTRICT**, a public corporation and political subdivision of the State of Nebraska, for and in consideration of One Dollar (\$1.00) and other valuable consideration, the receipt of which is hereby acknowledged, does hereby release and disclaim any rights it may have attained by virtue of the Plat and Dedication for Aksarben Center, an addition as surveyed, platted and recorded in Douglas County, Nebraska, over, upon, along and above the following described property:

A strip of land Ten (10) feet in width, being Five (5) feet on each side of and abutting the common side lot line of LOT Two (2) and LOT Three (3) Aksarben Center, now known as LOT One (1) and LOT Three (3) Aksarben Center Replat One, both subdivisions in Douglas County, Nebraska. **EXCEPT** the Southwesterly Five (5) feet on both the Southwesterly lot line of LOT Three (3) and the South lot line of LOT Two (2) and the North Five (5) feet on the North lot line of LOT Two (2) Aksarben Center.

AND a strip of land Ten (10) feet in width, being Five (5) feet on each side of and abutting the common side lot line of LOT Three (3) and LOT Four (4) Aksarben Center, now known as LOT One (1) and LOT Two (2) Aksarben Center Replat One, both subdivisions in Douglas County, Nebraska. **EXCEPT** the South Five (5) feet and East (8) feet thereof.
