

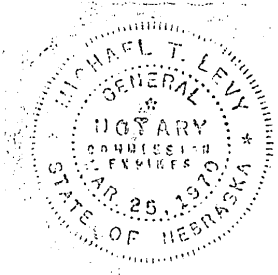


Exhibit A

EASEMENT TRACT I
