ORDINANCE NO. 959

AN ORDINANCE PROVIDING FOR THE CLOSING AND VACATING OF AN ALLEY IN THE CITY OF SEWARD, NEBRASKA AS DESIGNATED; TO PROVIDE FOR THE RESERVATION OF RIGHT-OF-WAY AND EASEMENT OF PUBLIC AND MUNICIPAL UTILITIES OF THE CITY AND OPEN AND CLOSE STORM SEWER AND WATER DRAINAGE; TO DECLARE THAT THE CLOSING AND VACATION IS EXPEDIENT AND FOR THE PUBLIC GOOD; TO PROVIDE FOR THE MANNER IN WHICH DAMAGES SUSTAINED BY THE CITIZENS OF THE CITY, OR BY THE OWNERS OF PROPERTY, THEREIN, SHALL BE ASCERTAINED; TO PROVIDE FOR A TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF SEWARD, NEBRASKA:

Section 1. ALLEY DESIGNATED; VACATED. The following designated and described alley in the City of Seward, Nebraska, namely:

The alley as platted, 14 feet in width, running north and south in Block 100, Harris, Moffitt and Roberts Addition to the City of Seward, Nebraska,

is hereby vacated and closed subject to the reservations in Section 2 of this Ordinance.

Section 2. RESERVATION OF EASEMENT BY CITY. The City of Seward reserves an easement and right of ingress and egress upon all of such vacated alley for the lawful purposes of the city for the construction, maintenance, repair and alteration of public and municipal utilities and open and close storm sewer and water drainage.

Section 3. VACATION FOR PUBLIC GOOD. Subject to the reservations of Section 2 hereof, the vacation of said alley is hereby delcared expedient/for the public good.

Section 4. CLAIMS FOR DAMAGES. All citizens of the City of

Seward and all owners of property therein sustaining or claiming damage

by reason of the vacation or closing of the alley shall file claims

therefore with the City Clerk of the City of Seward, on or before

August 17. 1973.

Section 5. WHEN OPERATIVE. This ordinance shall be in full force and take effect from and after its passage, approval and publication as provided by law.
