ORDINANCE NO. 12751

01 An Ordinance creating Sewer District No. 1094, providing for  
02 the payments of the costs of the improvements therein, designating the  
03 property to be benefited, and repealing all ordinances or parts of  
04 ordinances in conflict herewith.

05 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

06 Section 1. That Sewer District No. 1094 in the City of  
07 Lincoln, Nebraska, be and the same is hereby created; that said district  
08 shall include the following described real estate benefited, to-wit:  
09 all of Western State Industrial Tract and Western State Industrial Tract  
10 1st Addition; Lots 1 through 10, Block 2, and Lots 13 through 18, Block 5,  
11 Burlington Heights; and all that portion of the west 150 feet of Lot 91  
12 lying south of the north line extended of West 'L' Street, said Lot 91  
13 is an Irregular Tract located in the Northwest Quarter of Section 28,  
14 Township 10 North, Range 6 East of the Sixth Principal Meridian in the  
15 City of Lincoln, Lancaster County, Nebraska.

16 The cost of the construction of the sewers to accommodate said  
17 district shall be assessed against the property in said district bene-  
18 fited in proportion to the benefits, not exceeding the cost of said  
19 sewers.

20 Section 2. That all ordinances or parts of ordinances in conflict  
21 herewith, be and the same hereby are repealed.

22 Section 3. This ordinance shall take effect and be in force from  
23 and after its passage and publication according to law, but construction  
24 shall not be commenced until ordered by resolution by the City Council.
