## EASEMENT

THIS INDENTURE, made this 23 day of October, 1962, by and between ADRIAN A. FOE and DOROTHEA FOE, husband and wife, Parties of the First Part, and the CITY OF BELLEVUE, Party of the Second Part,

WITNESSETH, that for and in consideration of the sum of One and no/100 (\$1.00) Dollars, the receipt of which is hereby acknowledged, the Parties of the First Part have this day bargained and sold, and by these presents do bargain, sell, convey, transfer and deliver unto the Party of the Second Part, a permanent easement and right of way for the continued operation, maintenance, repair, alteration, inspection of the adjacent Bellevue Water Well Site, and to also construct, maintain and operate an electrical transmission line consisting of poles, wires and fixtures, with the right to alter or remove the same in whole or in part at any time.

The land affected by the grant of this easement is a tract of land lying wholly within the SE 1/4 of the SW 1/4 of Sec. 6, T 13N, R 14E of the 6th P.M. Sarpy County, Nebraska and more particularly described as follows:

Commencing at a point on the north line of the S 1/2 of the SW 1/4 of said Sec. 6 (1/16 section line), said point being on the west toe of the levee and 2,399 feet east of the N. W. corner of S 1/2 of the SW 1/4 of Sec. 6; thence southeasterly, along the west toe of the levee, a distance of 20.2 feet to the point of beginning; thence easterly, along a line parallel to and 20.0 feet southerly of said 1/16 section line, a distance of 51.1 feet to a point on the east toe of the levee; thence southeasterly, along the east toe of the levee; a distance of 103.0 feet to a point thence westerly along a line parallel to and 120.0 feet southerly of said 1/16 section line, a distance of 51.1 feet to a point which is the southeast derner of

The conditions upon which this easement is granted are hereby expressly made binding upon the successors and assigns of the Party of the Second Part.

The Parties of the First Part do hereby covenant with the Party of the Second Part that they are lawfully seized and possessed of the real estate above described, and that they have good and lawful right to convey it or any part thereof.
