Beginning at the Southeast corner of Lot Six (6), Block Twelve (12) and assuming the East line of Lots Six (6), Seven (7) and Eight (8) to bear North 00 degrees 33 minutes 15 seconds West; thence North 89 degrees 59 minutes 44 minutes West along the South line of Lot Six (6) a distance of 108.16 feet to the Easterly right of way of Interstate No. 80; thence Northwesterly along said right of way being on a 170.00 foot radius curve to the right a distance of 186.39 feet (having a chord bearing of North 35 degrees 03 minutes 00 seconds West and a chord distance of 177.19 feet) to the point of tangency; thence continuing along said right of way North 03 degrees 38 minutes 25 seconds West a distance of 138.56 feet; thence South 89 degrees 54 minutes 19 seconds East a distance of 215.98 feet; thence South 00 degrees 33 minutes 15 seconds East along the East line of Lots Six (6), Seven (7) and Eight (8) a distance of 282.99 feet to the point of beginning;

Beginning at the Northeast corner of Lot Ten (10), Block Twelve (12), Lawnfield; thence South 00 degrees 33 minutes 15 seconds East along the East line of said Lots Eight (8), Nine (9) and Ten (10), a distance of 317.00 feet; thence North 89 degrees 54 minutes 19 seconds West a distance of 30.00 feet; thence North 00 degrees 33 minutes 15 seconds East along a line 30.00 feet West of and parallel to the East line of said Lots Eight (8), Nine (9) and Ten (10), a distance of 317.00 feet to the North line of said Lot Ten (10); thence North 90 degrees 00 minutes 00 seconds East along said North line a distance of 30.00 feet to a point of beginning, as contained in document recorded in Book 582, Page 534 and in Book 589, Page 556;
