BE IT FURTHER RESOLVED that the City Comptroller be, and he hereby is, authorized and directed to issue warrants to pay said awards and further to pay the appraisers' fees and other expenses as set out in said report, the total thereof In the amount of Twonty-nine Thousand, Four Hundred Eighty-seven and 55/100 Dollars (\$29,487.55) to be paid from the proceeds of the Sewer Construction Bonds and charged to the "Benson Sewer Project".

REPORT OF COMMITTEE OF FREEHOLDERS UNDER ORDINANCE NO. 16191

TO THE HONORABLE MAYOR AND CITY COUNCIL OF THE CITY OF OMAHA:

Your Committee of Freeholders, duly appointed to appraise the real estate declared necessary to be appropriated under Ordinance No. 16191, reports as follows:

Each member of the Committee qualified as required by law.

An organization meeting of the Committee was held on March 18, 1949. By unanimous vote, Mr. Wayne Selby was named Chairman, and Mr. James B. Dugher, Secretary.

A date was fixed for public hearings of all owners of and persons interested in the property to be appropriated. Such hearings were held on the 5th and 6th days of May, 1949, at the hour of 2:00 P.M. on each date, in the Council Chamber, City Hall, Omaha, Nebraska. Subsequent to this date, various additional hearings were held either at the request of the owners or parties interested or their agents or representatives, or pursuant to notices served on such owners or parties interested.

Mr. George Knapp, a disinterested person, was duly appointed to serve notices upon the owners of and persons interested in the property sought to be appropriated of the time and place of said hearings. All owners of and persons interested in said property sought to be appropriated were duly and legally served with notice of the time and place of hearing as shown by Exhibits hereto attached. Notice by publication was duly and legally served upon owners Albert M. Kitchen and Merriweather J. Waugh, as to their interest in the property described as Tract 5 and located in Block 9, Bowling Green, an Addition in Douglas County, Nebraska. After diligent search and investigation, your Freeholders were unable to determine the address of said Kitchen and Waugh, if living, or their heirs or devisees, and, therefore, caused

service by publication to be made in the Omaha World-Herald.

At the time and place stated in the notices, or at such other times as were agreed upon by the owners or persons interested, the Committee met for the purpose stated in the notices and heard all owners of and persons interested in said real estate who presented themselves at said time and place. The Committee at these various hearings received testimony as to the value of the properties involved and the damages to the owners and persons interested by reason of the taking thereof.

Each member of the Committee viewed and inspected all real estate involved herein.

The Committee further considered all matters which, in its opinion, affected the value of the real estate taken and made awards to the owners and persons interested therein.

all taxes prior to the 1948 County and 1949 City on each of the tracts involved in this condemnation have been paid. In a majority of the instances, the taxes for these years have in fact also been paid. In such instances where the tax has not been paid, the City is taking only a small piece of the real estate belonging to the particular owner, and it would not be feasible to attempt to apportion the samll amount of tax due against the property which is to be taken. The awards are made subject to the understanding that the owners shall pay the small amount of current taxes which are due against the parcels of property taken by the City in this proceeding.


