WHOM IT MAY CONCERN:

Notice is hereby given that Metropolitan Utilities District has, under its construction order procedure, installed a water main, in the following streets:

On 72nd Street between Dodge Street and Howard Street and on 72nd Street between Pacific Street and a point approximately 865 feet north of the north property line of Pacific Street

in Omaha, Douglas County, Nebraska, or adjoining said city, abutting the lots or parcels of land described below:

- All of Lots 2, 3, 6, 7, 10, west 2/3 of Lot 11, Block 10, Cedarnole Addition East 132 feet, except street, of Sub Lot 1 of Tax Lot 5, in the southeast 1/4 of the southeast 1/4 of Section 23, Township 15, Range 12 east
East 132 feet, except street, of Sub Lot 2 of Tax Lot 5, in the southeast 1/4 of the southeast 1/4 of Section 23, Township 15, Range 12 east
East 132 feet, except street, of the south 150 feet of the north 630 feet in the southeast 1/4 of the southeast 1/4 of Section 23, Township 15, Range 12 east
West 132 feet, except street, of the south 200 feet of the north 630 feet in the southwest 1/4 of the southwest 1/4 of Section 24, Township 15, Range 12 east
West 132 feet, except street, of the south 660 feet, except street, in the southwest 1/4 of the southwest 1/4 of Section 24, Township 15, Range 12 east

A connection charge of \$ 1.75 per foot will be made as to each of said lots or parcels of land whose owners apply for, and receive, service from such main. This charge is in lieu of an assessment which would have been made if said main had been installed under the statutory procedure for main extensions. The connection charge may be paid in full, or in installments, as provided by the Rules and Regulations of Metropolitan Utilities District.

When the connection charge has been paid in full by the owner of a lot, a receipt will be issued and may be recorded by him. Inquiry may be made of the New "Services" Section of Metropolitan Utilities District as to whether a connection to said main has been made as to any one of the lots or parcels of land hereinabove described, and the amount of the connection charge remaining unpaid, if any.
