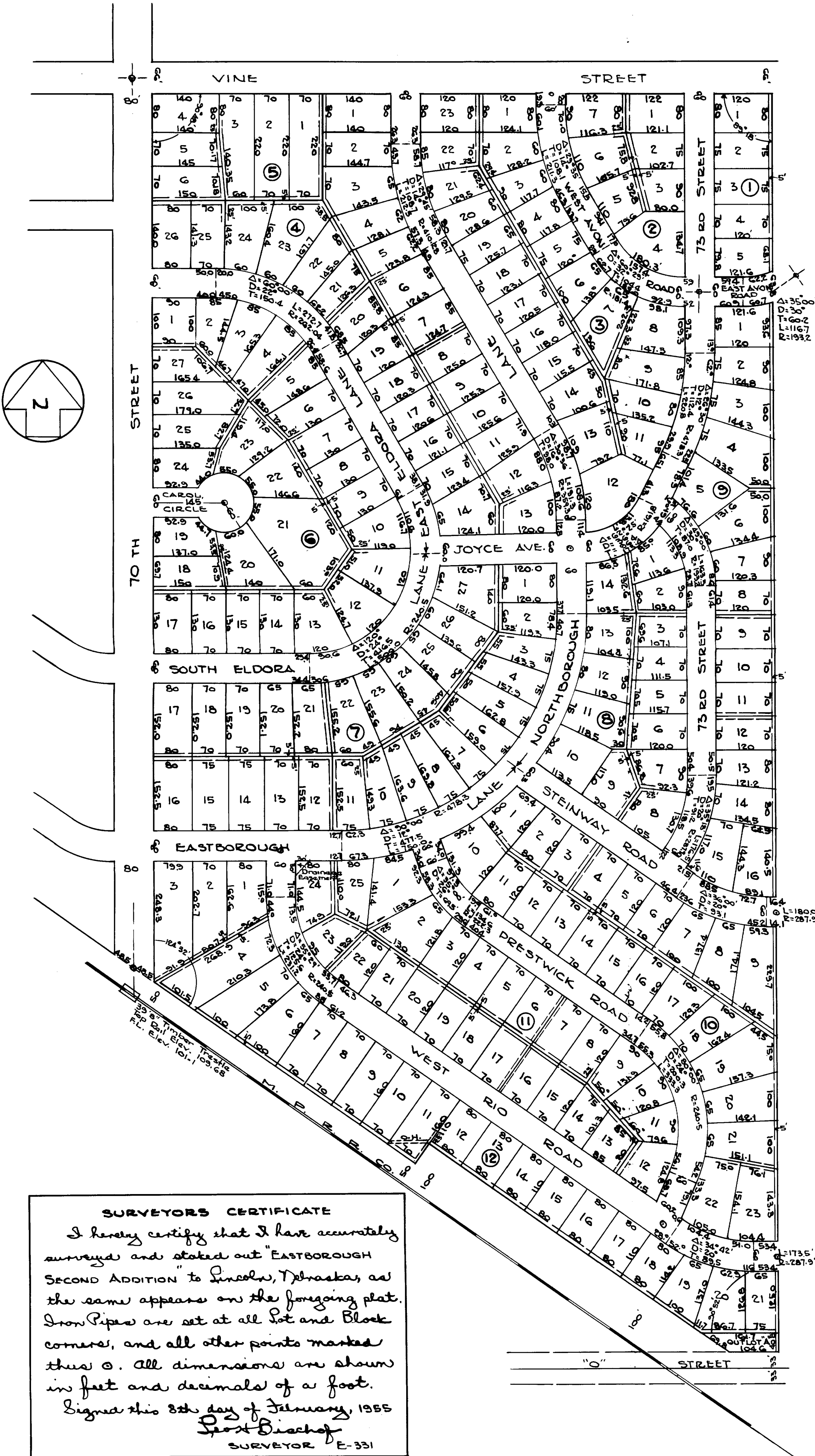


EASTBOROUGH SECOND ADDITION
