Now on this 8th day of March, 2018, this matter comes on for further consideration of Plaintiff's Motion for Summary Judgment. The Court has reviewed the evidence and arguments of counsel.

Plaintiff offered Exhibit 1, an affidavit that more fully details the basis of the claim in Plaintiff's complaint. Defendant filed a general denial herein and submitted no evidence at the hearing on the Motion for Summary Judgment. If Defendant had presented some minimum evidence to refute the allegations of the affidavit, the Court would have found summary judgment was not proper and the matter should proceed to trial. In light of what was presented, however, the Court does not find there is any genuine issue of material fact herein.

THEREFORE, the Court grants Plaintiff's motion for summary judgment in the amount of \$4095.59, plus pre-judgment interest in the amount of \$424.15, costs herein in the amount \$83.00, plus post judgment interest at the rate of 12%.

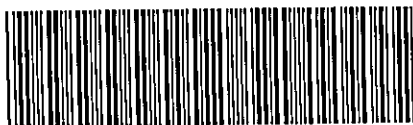
