## TRUSTEE'S DEED

LYNN E. OLSON, JILL L. BOBEK and JAY F. OLTMANNS, Successor Trustees of the Margaret J. Oltmanns Trust u/a/d July 22, 1994, pursuant to power therein, Grantor, in distribution pursuant to said Trust to Grantees, LYNN E. OLSON, JILL L. BOBEK and JAY F. OLTMANNS, conveys to Grantees as tenants in common the following described real estate in Douglas County, Nebraska (as defined in Neb. Rev. Stat. 76-201):

Lots 19 through 25, part of Lot 26, Westerly ½ of vacated alley adjacent to Easterly line of Lots 19 through 25, including a 16 foot strip adjacent to the westerly line of Lots 19 through 22, all within West Benson Subdivision of Lot 84 Keystone Park in the N.E. 1/4 Sec. 10, T15N, R12E of the 6th P.M., Douglas County, Nebraska; more particularly described as follows: Beginning at a point 16.94 West of the S.W. corner Lot 19 West Benson; thence N. 19°09'W. 352.50 feet; thence S.89°58'E. 126.44 feet to the point of beginning. Said tract contains 42,091 square feet or 0.966 acres. Note. The South line of the N.E. 1/4 Section 10-15-12 assumed to bear East-West.

The South 98 feet of Lot 5, Block 18, in West Benson, an Addition as surveyed, platted and recorded in Douglas Courts 11 except the East 20 feet thereof, and excepting thereof that part deeded to the County of Douglas, more particularly described as follows: Beginning at a point 407.74 feet West of the Southeast corner of Lot 5, Block 18, West Benson Addition, thence West along the South line of said Lot 5, a distance of 214.36 feet to the southwest corner of said Lot 5, thence Northwesterly along the West line of said Lot 5, for a distance of 80.0 feet, thence Northwesterly along said West line a distance of 32.0 feet to a point 98 feet North of the South line of said Lot 5, thence East along a line 98 feet North of and parallel to the South line of said Lot 5, for a distance of 109.0 feet more or less to a point 521.2 feet West of the East line of said Lot 5, thence Southeasterly on a curve to the left whose delta angle is 55°44'51" with a radius of 159.15 feet for an arc of 93.02 feet, thence South 67°19'33" East for a distance of 80.34 feet, thence Southeasterly on a curve to the right, whose delta angle is 61°49'08" with a radius 572.96 feet for an arc length of 7.25 feet to the point of beginning,

Block 18, West Benson Addition, 265.03 feet West of the Southeast corner of said Lot 4; thence West along said South line for a distance of 136 feet more or less to the Southwest corner of said Lot 4; thence Northwesterly along the West line of said Lot 4, for a distance 61.9 feet; thence Northwesterly along the West line of said Lot 4, for distance of 131.5 feet to the Northwest corner of said Lot 4, thence East along the North line for a distance of 87 feet more or less to a point 386.62 feet West of the Northeast corner of said Lot 4, thence Southeasterly on a curve to the right whose delta angle is 61°91'08" with a radius of 572.96 feet for a distance of 225.12 feet to the point of beginning.
