During Residual District No. 521 of Douglas County, Nebraska and makes the following statement regarding it:

- 1. District Number: 521
- 2. Outer Boundaries: See Exhibit A and Exhibit B, which are attached hereto and incorporated herein by this reference.
- The purpose of this District shall be acquiring, installing, repairing, 3. maintaining, renewing, operating and replacing electrical service lines and conduits, a sewer system, a water system, a system of sidewalks, public roads, streets and highways, a civil defense warning system, to contract for water for fire protection and for resale to the residents of the District, and to contract for gas and electricity, for street lighting for the public streets and highways within the District and to acquire, improve, operate and contract for public parks, playgrounds and recreational facilities. The District shall have all of the powers and authorities as are permitted by law, to achieve the purposes herein above set forth, including but not in limitation of the foregoing, the power and authority to contract with corporations, utility companies, districts or municipalities for water for fire protection and for resale to the residents of the District, and for electricity and gas, for street lighting of the public streets and highways within the District and for the disposal of sewage in the use of existing sewer improvement facilitites and for the operation and maintenance of electrical service lines and conduits.
- 4. The District has the power to levy and unlimited property tax to pay its debts and expenses of operation and maintenance.

- 5. The District is required by statute to levy special assessments on property in the District to the full extent of special benefits arising by reason of improvements installed by it.

- 7. The actual current levy of the District may be obtained from the County Clerk.

8. A copy of the District's annual financial audit is on file with the Clerk of the District and the State Auditor of Public Accounts.
