NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, Grantors do by these presents give, grant and convey unto Grantee, its successors and assigns until July 31, 2018 the right to maintain said steam lines, steam return lines and hot water lines as they presently exist on Grantors' property together with the right to enter upon Grantors' property for the purpose of inspecting, repairing, maintaining and replacing said lines.

The easement granted hereby shall be binding upon the Grantors and upon their heirs and assigns.


