BE IT RESOLVED by the Board of County Commissioners
of Lancaster County, Nebraska, in regular session assembled
this 30th day of April, 1974, in the County-City Building in
Lincoln, Lancaster County, Nebraska, as follows:

WHEREAS, by Resolution #2864 the County Engineer and
Highway Commissioner of Lancaster County is directed to study
and report his recommendations as to the vacation and abandon-
ment of a certain county road described as follows:

The East 33 feet of the North 567 feet
of the South 600 feet of the Southeast
Quarter (SE 1/4) Section 35, Township 9
North, Range 6 East of the 6th P.M. and
the West 33 feet of the North 567 feet
of the South 600 feet of the Southwest
Quarter (SW 1/4) Section 36, Township 9
North, Range 6 East of the 6th P.M.,
Lancaster County, Nebraska.

WHEREAS, the County Engineer and Highway Commissioner
has made a written report as to his recommendations with regard
to the above-named street, and has recommended that it be aban-
doned, and that the City-County Planning Commission has also
approved the abandonment of the above described county road, and

WHEREAS, pursuant to Resolution 2864, a public hearing
was held by this Board on the 23rd day of April, 1974, on the
question of whether to vacate and abandon the above described
county road, and

WHEREAS, no objections to the vacation and abandonment
of the above described county roads were made at the hearing
held before this Board on the above date.

NOW, THEREFORE, BE IT RESOLVED that the following described county road and right of way:

The East 33 feet of the North 567 feet of the South 600 feet of the Southeast Quarter (SE 1/4) Section 35, Township 9 North, Range 6 East of the 6th P.M. and the West 33 feet of the North 567 feet of the South 600 feet of the Southwest Quarter (SW 1/4) Section 36, Township 9 North, Range 6 East of the 6th P.M., Lancaster County, Nebraska

be and the same is hereby vacated and abandoned, and that the same is reverted to the owners of the adjacent real estate, one-half to each side thereof.
