 Receipt that was sent to him, however, the cashing of the

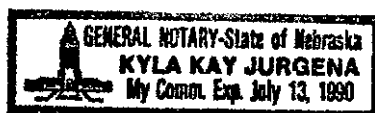



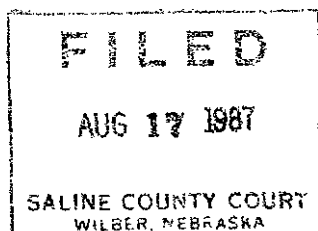
