20	the building line district is needed for public use as determined by the City in its sole
21	discretion

- 2. The Permittee shall sign and return the attached letter of acceptance agreeing to the terms and conditions of this approval with the City Clerk.
- 3. No building permit for installation of the light pole will be issued until this resolution and the Letter of Acceptance have been filed of record with the Register of Deeds.
 - 4. The terms, conditions, and requirements of this resolution shall run with the land and be binding on the Permittee, its successors, and assigns.
 - 5. The City Clerk shall file a copy of this resolution approving the location of the light pole in the building line district and the letter of acceptance with the Register of Deeds, filing fees therefor to be paid in advance by the Permittee.
