ASSIGNMENT OF BENEFICIARY'S INTEREST IN DEED OF TRUST

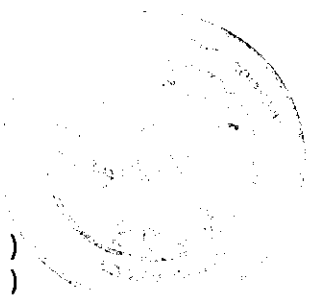
