AN ORDINANCE TO APPROVE THE PLAT ENTITLED "FINAL PLAT COUNTRY CLUB HEIGHTS SECOND ADDITION, A REPLAT OF LOTS 1 THROUGH 14 INCLUSIVE, BLOCK 2, COUNTRY CLUB HEIGHTS FIRST ADDITION TO THE CITY OF SEWARD, SEWARD COUNTY, NEBRASKA," AS HEREINAFTER SET FORTH, LOCATED AT THE NORTHWEST CORNER OF HILLCREST DRIVE AND AUGUSTA DRIVE; TO PROVIDE FOR PUBLICATION OF THIS ORDINANCE IN PAMPHLET FORM; TO PROVIDE FOR A TIME WHEN THIS ORDINANCE SHALL TAKE EFFECT.
