PARTIAL RELEASE OF EASEMENT

ALL UTILITY EASEMENTS ABUTTING ALL FRONT, SIDE AND REAR BOUNDARY LOT LINES OF ALL LOTS, CHERRY HILLS VILLAGE, AS SURVEYED, PLATTED AND RECORDED IN DOUGLAS COUNTY, NEBRASKA, NOW KNOWN AS LOTS TWO (2) AND LOTS FOUR (4) THRU TEN (10), INCLUSIVE, CHERRY HILLS VILLAGE REPLAT, A SUBDIVISION IN SAID DOUGLAS COUNTY AND LOTS ONE (1) AND TWO (2), CHERRY HILLS VILLAGE REPLAT 2, A SUBDIVISION IN SAID DOUGLAS COUNTY.

THE WESTERLY ONE HUNDRED FEET (100') OF THE COMMON SIDE LOT LINE EASEMENT BETWEEN LOTS ONE (1) AND THREE (3) OF CHERRY HILLS VILLAGE REPLAT, NOW KNOWN AS LOT ONE (1) AND TWO (2), CHERRY HILLS VILLAGE REPLAT 2, AS SURVEYED, PLATEED AND RECORDED IN DOUGLAS COUNTY, NEBRASKA.

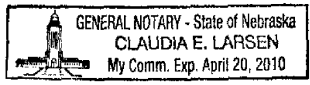
