 Wilber First addition to the town of Wilber is situated on the North East Quarter of the South West Quarter of Section No Fifteen, Township Six (6) North of Range Four East of the 6th P.M. in Saline County, Nebraska.

The Streets and alleys run at right angles with the Quarter Section lines North and South and East and West through Section 15 Township Six (6) North of Range Four East.

all streets are seventy feet wide alleys are all ~~streets~~ alley twelve feet (12) wide.

Ordinary sized lots are forty four (44) by one hundred and thirty two (132) ft. business lots are twenty two (22) by one hundred and thirty two (132) or one half the size of ordinary sized lots.

The size of all lots, Streets and alleys are designated in feet on the map. There are stakes driven at the front corners of each lot.
