ORDINANCE NO. 768

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA CREATING STREET IMPROVEMENT DISTRICT NO 99-1 IN THE CITY OF LA VISTA, NEBRASKA, ORDERING THE CONSTRUCTION OF STREET IMPROVEMENTS THEREIN AND ORDERING THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, SARPY COUNTY, NEBRASKA:

SECTION 1. That there be and hereby is created in the City of La Vista, Nebraska, a street improvement district to be known and designated as Street Improvement District No. 99-1 of the City of La Vista, Nebraska.

SECTION 2. That the outer boundaries of Street Improvement District No. 99-1 of the City of La Vista, Nebraska shall, in addition to the street to be improved, include all property abutting said street, including, but not limited to, Lots 3, 4, 5 and 6 of Willowbrook, an addition to the City of La Vista, Nebraska, and within which district the following shall be improved by the extension of Brentwood Drive from Elm Drive to Chinawood Avenue, widening of Brentwood Drive from two lanes to three lanes from the intersection of Chinawood Avenue to 84th Street, intersection improvements including signalization at the intersection of Granville Parkway and Brentwood Drive, portland cement pavement, construction of storm sewer inlets, milling of existing pavement and asphaltic overlay, median construction work, sidewalk and retaining wall improvements, and all other necessary appurtenances thereto:

Brentwood Drive from 84th Street to a point approximately 250 feet west of the intersection of Brentwood Drive and Elm Drive.


SECTION 3. Said streets shall be improved and said improvements shall be made in accordance with the plans, specifications and estimate prepared by the special engineer employed for the project. The Mayor and Council shall, upon completion of the project, have the authority to levy special assessments against the property within the district specifically described herein as such property may be specifically benefitted thereby.

SECTION 4. Notice of the creation of said District shall be published as provided by law in The Times, a legal newspaper published and of general circulation in La Vista, Nebraska.


SECTION 5. This ordinance shall be published in pamphlet form and take effect as provided by law.
