
Deed to Trust



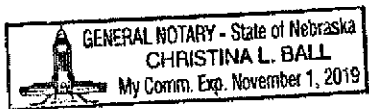
