

ORDINANCE NO. 315

AN ORDINANCE OF THE CITY OF WILBER, SALINE COUNTY, NEBRASKA, VACATING THE WAY USED AS AN ALLEY RUNNING NORTH AND SOUTH BETWEEN LOTS NUMBERED ONE (1), TWO (2), THREE (3), FOUR (4), THIRTEEN (13), FOURTEEN (14), FIFTEEN (15) AND SIXTEEN (16), IN BLOCK NUMBERED FOUR (4) IN WILBER'S THIRD ADDITION TO THE CITY OF WILBER, SALINE COUNTY, NEBRASKA, AND RUNNING NORTH AND SOUTH BETWEEN LOTS NUMBERED FIFTEEN (15) AND SIXTEEN (16) IN REED'S NORTH ADDITION TO THE CITY OF WILBER, SALINE COUNTY, NEBRASKA; TO REPEAL ALL ORDINANCES OR PARTS THEREOF IN CONFLICT HERewith AND PROVIDING FOR THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.


BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF WILBER, SALINE COUNTY, NEBRASKA:

SECTION 1. That in pursuance to Petition duly presented by all the owners of real estate abutting thereon, the way which has been used as an alley running North and South between Lots Numbered One (1), Two (2), Three (3), Four (4), Thirteen (13), Fourteen (14), Fifteen (15) and Sixteen (16), in Block Numbered Four (4) in Wilber's Third Addition to the City of Wilber, Saline County, Nebraska, and running North and South between Lots Numbered Fifteen (15) and Sixteen (16) in Reed's North Addition to the City of Wilber, Saline County, Nebraska, be, and the same hereby is, vacated as an alley.

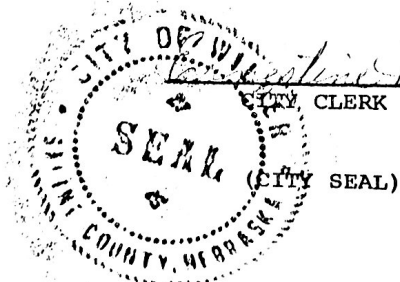
SECTION 2. All prior Ordinances or parts thereof in conflict herewith are hereby repealed.



BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF WILBER, SALINE COUNTY, NEBRASKA:

SECTION 1. That in pursuance to Petition duly presented by all the owners of real estate abutting thereon, the way which has been used as an alley running North and South between Lots Numbered One (1), Two (2), Three (3), Four (4), Thirteen (13), Fourteen (14), Fifteen (15) and Sixteen (16), in Block Numbered Four (4) in Wilber's Third Addition to the City of Wilber, Saline County, Nebraska, and running North and South between Lots Numbered Fifteen (15) and Sixteen (16) in Reed's North Addition to the City of Wilber, Saline County, Nebraska be and the same hereby is, vacated as an alley.

SECTION 2. All prior Ordinances or parts thereof in conflict herewith are hereby repealed.

SECTION 3. This Ordinance shall take effect and be in full force from and after its passage, approval, adoption and publication, as provided by law.
