thereon has been given as is provided for by law, and

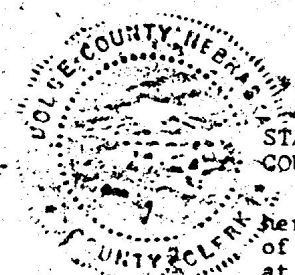
WHEREAS this Board upon consideration of the facts finds:

1. The hereinafter described tract is suitable for use  
as an industrial area;
2. It will be generally beneficial to the community to  
have the same so designated and used.
3. The owners of the land have consented to have the  
same designated as an industrial area as is provided for  
by law.

NOW THEREFORE, it is resolved that the following described  
real estate be designated as an industrial area as is provided  
for in Chapter 19, Article 25 of 1943 Revised Statutes of  
Nebraska as amended.

RANGE EIGHT, EAST OF THE SIXTH P. M. DODGE COUNTY, NEBRASKA,  
DESCRIBED VIZ:

THAT PART OF THE EAST HALF OF THE NORTHWEST QUARTER  
LYING SOUTH OF THE CHICAGO, BURLINGTON & QUINCY RAILROAD  
COMPANY RIGHT OF WAY AND NORTH OF THE CHICAGO & NORTH-  
WESTERN RAILWAY COMPANY RIGHT OF WAY; ALSO,  
THAT PART OF TAX LOT 12 IN THE NORTHEAST QUARTER OF  
THE SOUTHWEST QUARTER LYING NORTH OF THE CHICAGO AND  
NORTHWESTERN RAILWAY COMPANY RIGHT OF WAY; ALSO,  
THAT PART OF THE WEST HALF OF THE NORTHEAST QUARTER  
LYING NORTH OF THE CHICAGO & NORTHWESTERN RAILWAY  
COMPANY RIGHT OF WAY;
