RESTRICTIVE COVENANTS

The undersigned (Owner) is the owner of the following-described real estate:

These Restrictive Covenants are established upon the real estate.

- 1. <u>USE RESTRICTIONS</u>: Kinko's, Inc., a Delaware corporation (Kinko's") is currently a tenant in the Condominium occupying a portion of Unit A. - 4. <u>TERMINATION</u>: These Restrictive Covenants shall automatically terminate and be of no further force or effect when Kinko's no longer legally occupies any portion of a unit within the Condominium.
