

ASSIGNMENT OF RIGHT-OF-WAY EASEMENTS

This Assignment made the 29th day of March, 1974, by Nebraska Public Power District (formerly Consumers Public Power District), hereinafter referred to as "Nebraska District," to Norris Public Power District, hereinafter referred to as "Norris District."

WITNESSETH:

WHEREAS, Nebraska District and Norris District entered into an Agreement providing for the exchange and sale of certain properties and facilities dated May 12, 1973; and

WHEREAS, paragraph 5 of said Agreement requires Nebraska District to assign certain right-of-way easements to Norris District; and

WHEREAS, the right-of-way easements had been acquired from certain landowners by either Iowa-Nebraska Light and Power Company, Consumers Public Power District or Nebraska Public Power District, and Nebraska District is the successor in interest of Iowa-Nebraska Light and Power Company, Consumers Public Power District and Nebraska Public Power District.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and pursuant to the provisions of said Agreement, Nebraska District hereby sells, conveys, assigns and transfers to Norris District the right-of-way easements described in certain documents which are listed generally by giving the names of the grantors, the date of the execution of the easement, the description of the land on which the easement is located, the date the easement was recorded and the book and page number of said recordings, and attached hereto as Exhibit B-3.

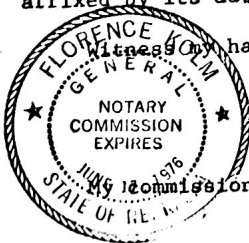
