

TRACT NO. 1:

THAT PART OF TAX LOT 3, LOCATED IN A PART OF THE SOUTH HALF OF THE NORTHWEST QUARTER OF SECTION 31, TOWNSHIP 17 NORTH, RANGE 9 EAST OF THE SIXTH P.M., DODGE COUNTY, NEBRASKA, LYING SOUTH AND WEST OF THE SOUTHERLY RIGHT-OF-WAY LINE OF THE UNION PACIFIC RAILROAD BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHWEST CORNER OF SAID SOUTH HALF NORTHWEST QUARTER AND ASSUMING THE NORTH LINE OF THE NORTHWEST QUARTER OF SAID SECTION 31 TO HAVE A BEARING OF \$90°00'00"E; THENCE \$00°04'56"E ON THE WEST LINE OF SAID SOUTH HALF NORTHWEST QUARTER AND SAID TAX LOT 3, A DISTANCE OF 146.16 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING \$00°04'56"E ON SAID WEST LINE, A DISTANCE OF 913.85 FEET; THENCE \$90°00'00"E PARALLEL WITH THE NORTH LINE OF SAID NORTHWEST QUARTER, A DISTANCE OF 358.48 FEET; THENCE \$90°00'00"W PERPENDICULAR TO SAID NORTH LINE, A DISTANCE OF 342.00 FEET; THENCE \$90°00'00"E PARALLEL WITH SAID NORTH LINE, A DISTANCE OF 239.00 FEET; THENCE \$90°00'00"W PERPENDICULAR TO SAID NORTH LINE, A DISTANCE OF 571.85 FEET; THENCE \$90°00'00"W PARALLEL WITH SAID NORTH LINE, A DISTANCE OF 598.79 FEET TO THE POINT OF BEGINNING, CONTAINING A COMPUTED AREA OF 10.67 ACRES OF WHICH 0.66 ACRES IS PUBLIC ROAD RIGHT-OF-WAY.

THE SOUTHERLY RIGHT-OF-WAY LINE OF THE UNION PACIFIC RAILROAD, SAID POINT ALSO BEING THE NORTHWEST CORNER OF SAID TAX LOT 2; THENCE S44°25'05"E ON SAID SOUTHERLY RIGHT-OF-WAY LINE, A DISTANCE OF 3403.15 FEET TO A POINT OF INTERSECTION WITH THE SOUTH LINE OF SAID SOUTH HALF NORTHWEST QUARTER, SAID POINT ALSO BEING THE SOUTHEAST CORNER OF SAID TAX LOT 3; THENCE N89°55'28"W ON SAID SOUTH LINE, A DISTANCE OF 2385.31 FEET TO THE POINT OF BEGINNING, CONTAINING A COMPUTED AREA OF 55.79 ACRES, MORE OR LESS.
