DECLARATION OF CONSERVATION EASEMENT

THIS DECLARATION OF CONSERVATION EASEMENT ("Declaration") is made as of this 9th day of August, 2819, by SANITARY AND IMPROVEMENT DISTRICT NO. 290 OF SARPY COUNTY, NEBRASKA, a Nebraska political subdivision ("Grantor").

PRELIMINARY STATEMENT

Grantor is the owner of the parcels of land described on Exhibits "A", "B", "C", "D", "E", "F", "G" and "H" attached hereto and incorporated herein by this reference (hereinafter collectively referred to as the "Parcels"). Grantor desires to establish a permanent easement for the right to construct, operate, repair, replace and maintain a conservation and buffer zone and all utilities and structures appurtenant thereto, under and over the portions of the Parcels (hereinafter referred to as the "Easement Areas").

NOW, THEREFORE, Grantor hereby declares and establishes the following Easement:


- 1. Grantor hereby reserves, establishes and creates a perpetual and permanent easement for the right to construct, operate, repair, replace and maintain a conservation and buffer zone under and over the Easement Areas, together with the reasonable right of access for the purpose of inspecting and maintaining the conservation and buffer zone and all utilities and structures appurtenant thereto.
 - 2. The Easement Areas are subject to the following land use restrictions:
 - a. The Easement Areas will be maintained by the Grantor pursuant to the conditions identified in the U.S. Army Corps of Engineers Permit No. 2009-01961-WEH for tree mitigation.
 - b. There shall be no construction or placement of structures or mobile homes, fences, signs, billboards or other advertising material, or other structures, whether temporary or permanent, in, on, over or across the Easement Areas.
 - c. There shall be no removal, destruction, or cutting of trees or plants; spraying with biocides, insecticides, or pesticides; grazing of animals, farming, tilling of soil, or other agricultural activity. Management activities for trees are acceptable upon approval by the Corps of Engineers.
 - d. There shall be no operation of all-terrain vehicles or any other type of motorized vehicle on the Easement Areas except as needed for maintenance.
