**TRUSTEE'S DEED**

KNOW ALL MEN BY THESE PRESENTS:

That a Deed of Trust was made and entered into on or about March 20, 2015, by and between Stephanie R. Janda and Tyler J. Janda, as wife and husband, as Trustors, and Mortgage Electronic Registration Systems, Inc., Beneficiary, wherein Lincoln Federal Savings Bank of Nebraska was named Trustee. This Deed of Trust was recorded March 20, 2015 in the Records of the Register of Deeds of Lancaster County, Nebraska as Instrument No. 2015010376.

On or about April 5, 2017, Mortgage Electronic Registration Systems, Inc., Beneficiary, assigned all of its right, title and beneficial interest in the Deed of Trust to MidFirst Bank, a Federally Chartered Savings Association. The Assignment was recorded April 19, 2017, in the office of the Register of Deeds of Lancaster County, Nebraska, as Instrument No. 2017015520.

Camille R. Hawk, Attorney at Law, has been appointed Successor Trustee, pursuant to a Substitution of Trustee filed for record with the Register of Deeds of Lancaster County, Nebraska. Hereinafter the Successor Trustee, Camille R. Hawk, Attorney at Law, will be referred to as GRANTOR.

The GRANTOR in consideration of **One Hundred Ten Thousand Nine Hundred Fifty Dollars and No Cents (\$110,950.00)** and other valuable consideration received from **CKR Properties, LLC**, hereinafter GRANTEE, does hereby grant, bargain, sell, convey and confirm unto GRANTEE the following described real property in Lancaster County, Nebraska:

Lot 1, Block 1, Walnut Park Addition, Lincoln, Lancaster County, Nebraska

To have and to hold the above-described premises together with all tenements, hereditaments and appurtenances thereto belonging unto the GRANTEE, and to the GRANTEE'S successors and assigns forever.

GRANTOR does hereby covenant with the GRANTEE and with the GRANTEE'S successors and assigns:

(1) That Stephanie R. Janda and Tyler J. Janda, as wife and husband, as Trustors, failed to pay the Beneficiary payments which were contractually due, and the GRANTOR, at the request of the Beneficiary, elected to declare the entire unpaid principal balance, together with interest thereon, at once immediately due and payable.

(2) That a Notice of Default was recorded by GRANTOR on August 19, 2019, as Instrument No. 2019031216, in the records of the Register of Deeds, Lancaster County, Nebraska. Within ten (10) days thereafter, a copy of the recorded Notice of Default was mailed by certified mail, postage prepaid, to all parties entitled to notice, pursuant to said Deed of Trust and in compliance with Neb. Rev. Stat. § 76-1008.

(3) That Trustors, Stephanie R. Janda and Tyler J. Janda, as wife and husband, failed to cure the default referenced in the Notice of Default within 30 days after the recording of the Notice of Default.

(4) That a Notice of Trustee's Sale was executed by GRANTOR. At least twenty (20) days prior to the date of sale, a copy of the Notice of time and place of the Trustee's Sale was mailed by certified mail, postage prepaid, to all parties entitled to notice, pursuant to said Deed of Trust and in compliance with Neb. Rev. Stat. § 76-1008.

(5) GRANTOR published the Notice of Trustee's Sale, to be held on November 12, 2019 at 9:00 a.m., inside the East door of the Lancaster County Courthouse, Justice and Law Enforcement Center (10th St entrance) 575 S. 10th Street, Lincoln, Lancaster County, Nebraska, which notice was published in *The Lincoln Journal Star* of Lincoln, Nebraska, once a week for five (5) consecutive weeks, commencing on September 28, 2019, and ending October 26, 2019. The last publication of Notice was at least ten (10) days prior to the Trustee's Sale, held on November 12, 2019, and said sale was not later than thirty (30) days after the last publication of Notice.


(6) GRANTOR conducted the sale of the real property at public auction on November 12, 2019 at or about 9:00 a.m., inside the East door of the Lancaster County Courthouse, Justice and Law Enforcement Center (10th St entrance) 575 S. 10th Street, Lincoln, Lancaster County, Nebraska. GRANTOR accepted the bid of **CKR Properties, LLC**, in the sum of **One Hundred Ten Thousand Nine Hundred Fifty Dollars and No Cents (\$110,950.00)** as the highest bid upon said real property. GRANTOR has complied with the requirements of Neb. Rev. Stat. §§ 76-1001 through 76-1018, in the exercise of the sale of the real property described herein at the Trustee's Sale held on November 12, 2019.

This Deed shall operate to convey to the GRANTEE, the GRANTOR'S title and all right, title, interest and claim of the Trustors, and their successors in interest and of all persons claiming by, through or under them, in and to the above-described real property, including all such right, title, interest and claim in and to such property acquired by the Trustors or their successors in interest subsequent to the execution of the Deed of Trust.

This Deed is subject to all easements, restrictions or covenants of record which GRANTOR is not entitled to convey pursuant to Neb. Rev. Stat. § 76-1010(2).

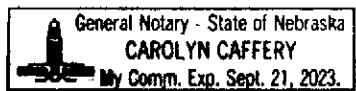


