That portion of the SE½NW½ of Section 12, T14N, R12E, 6th P.M., Douglas County, Nebraska, described as follows, to-wit:

Beginning at the center of said Section 12; thence Westerly along the East-West centerline of said Section 12 a distance of 1320.0 feet to the Southwest corner of said SEŁNWŁ; thence Northerly along the West line of said SEŁNEŁ to the point of intersection with a line drawn parallel with and distant 50.0 feet Southerly of, as measured at right angles to, Burlington Northern Railroad Company's (formerly Chicago, Burlington and Quincy Railroad Company's) hereinafter described Main Track centerline; thence Easterly parallel with said Main Track centerline to the point of intersection with the North-South centerline of said Section 12; thence Southerly along said North-South centerline to the Point of Beginning.

Main Track Centerline Description

Commencing at the Southwest corner of the SWŁNWŁ of Section 12, T14N, R12E, 6th P.M., Douglas County, Nebraska; thence Northerly along the West line of said Section 12 a distance of 376.55 feet to the True Point of Beginning of the Main Track centerline to be described; thence Southeasterly, deflecting 93°13' to the right, to the point of intersection with the North-South centerline of said Section 12 and there terminating.
